## Registration@Work

The Registrations Division, notwithstanding the challenges due to the minimum health, safety and social distancing measures to address, prevent and combat the spread of COVID-19 and the lockdown restrictions, continues to make every effort for the speedy finalisation of applications for registration with the SACSSP. Since the beginning of August until the 13<sup>th</sup> of August 2021 a total of 534 applications for registration were processed, which resulted in the registration of 78 social workers, 196 student social workers, 30 social auxiliary workers, 124 student social auxiliary workers, 11 child and youth care workers at professional level, 27 child and youth care workers at auxiliary level and 68 student child and youth care workers. The Division also issued 49 certificates of status of good standing (registration status report), responded to 2,151 verification of registration status requests from employers and completed 28 verifications of qualifications obtained outside the country in terms of section 17D of the Act.
