#Annual Fees

Happy New Year! Our office reopened on 6 January 2020 and we are ready for the New Year. It is encouraging to see that registrants are paying their annual fees for 2020/21. Registration and annual fees for 2020/21 are available on our website www.sacssp.co.za under Registration Please bear with us if you receive an invoice and you have already paid. The finance division is in the process of updating the payments received. Registrants who are up to date with payments of annual fees and/or other fees due to Council will be issued with receipts in due course. At the start of the year we wish to share with you a few pointers that will assist you with paying for registration:

1. REGISTERED PRACTITIONERS

Persons already registered with the South African Council for Social Service Professions must quote their registration number as a reference when making a payment starting with either: 10-, 50-, 70_{-} or 90_{-}

- 2. Persons registering for the first time on the social work register Use 60 -plus the first 5 numbers of Identity Number (ID). For example, if your ID number is 980505 5482 082, the reference number will be 60 98050.
- 3. Persons registering for the first time on the child and youth care register Use 18 - plus the first 5 numbers of Identity Number (ID). For example, if your ID number is 980505 5482 082, the reference number will be 18 98050.
- 4. Existing students applying for professional registration

Students who are currently studying social work and child and youth care work who already have a registration number (from their second year of study) should use their student registration number as reference when making payment for when the apply to register after completion of their studies as social worker, social auxiliary worker, child and youth care worker or child and youth care worker at auxiliary level.

HOW TO GET YOUR ANNUAL FEE RECEIPT QUICKER?

The first three months of every year creates a particular challenge when social service practitioners pay their annual fees, which was due on 1 January. The biggest challenge every year is that a very large number of social service practitioners pay their annual fees in the last week of March or on 31 March. This cause a bottleneck and delays in the issuing and dispatching of receipts, and is often made worse when payments are done with incorrect reference numbers. This can be avoided with payments being made on time with correct reference numbers

HOWEVER, if you make your payment early e.g. November or December, and if after 1 January, during the first two months of the year, the workload in the finance division is manageable and your payment is processed, and receipts are sent out within a few days after payment.

TIP FOR 2020

Help us to get your receipt to you quicker. Pay your annual fees TODAY.

Remember: Always use your SACSSP registration number as reference when you make a payment. If you are unsure of which number to use, please contact the registration division. The reference number is the only way in which your payment can be traced in Council's bank account.

ETHICS. PROFESSIONAL CONDUCT & YOU

During the past two years Council noted with concern an increasing number of complaints of unprofessional or improper conduct against social service practitioners. The complaints were related to negligence in the performance of professional duties: ill-treatment of clients: dishonesty; failure to keep records of services rendered; engaging in private practice work without approval of the primary employer; fraudulent activities involving the submission of claims to medical aid schemes for services not rendered: and social grants. In a recent disciplinary inquiry in KwaZulu-Natal a social worker was found guilty of unprofessional or improper conduct of defrauding a medical aid scheme of more than R1 million by submitting claims of services not rendered. The penalty imposed in terms of section 22(1)(c) of the Social Service Professions Act 110 of 1978 was the immediate cancellation of her registration and that she is not allowed to practice social work anymore.

Council published, the particulars of persons found quilty of unprofessional conduct by the South African Council for Social Service Professions during the period July 2018 to June 2019 after a disciplinary inquiry that was instituted in its 2019 Newsletter and these will also be published in the Government Gazette as contemplated in regulation 22(10)(b) of the Regulations regarding the conducting of inquiries into alleged unprofessional conduct (Government Notice R 917 in Government Gazette Number 25109 of 27 June 2003).

Council, as part of its obligation to promote ethical conduct amongst social service practitioners. is providing WORKSHOPS ON THE CODES OF ETHICS for social service practitioners, free or charge. NOT JUST ANOTHER WEEK

On 17 February 2020, fifteen unemployed individuals commenced their 12 months internship programme and amongst them there are seven (7) Bachelour in Social Work graduates and the other eight (8) have qualifications such as National Diploma in Marketing, National Diploma in Legal Assistance, BA Communications, BA Youth Development and BCom Accounting. The interns received an induction on the mandate of Council. We wish the interns all of the best with their internship.

On the same date, a Registration Open Outreach Session led by the Registrar, supported by two registrations officials, a Council and a Professional Board Member, took place at Leliebloem Child and Youth Care Centre in Cape Town. Focus was amongst other issues on the SACSSP elections 2020/21: value of professional registration; continuing professional development (CPD); and codes of ethics. Robust engagements took place and the Registrar and the two Members, Ms Allsopp and Ms Zingu, answered guestions posed. A total of 195 social service professionals heeded the call and the last practitioner was served at 19h05. The registration helpdesk attended to 119 enquiries, with 35 certificates and 28 receipts processed. The Registrar also supported the oath taking ceremony of 2nd year social work students at the University of Stellenbosch. Key to Registrar's presentation was to create awareness around the obligations and responsibilities that comes with being a registered social service professional and the code of ethics.

On 21 February 2020, Council's management had a benchmarking meeting with the South African Pharmacy Council to build relations and to share best practise.

AS WE ENTER MARCH 2020

The Professional Board for Child and Youth Care Work (PBCYC) held its 39th meeting on 27 and 28 February 2020 in Pretoria. A range of topics were covered in the robust discussions, and significant milestones were reached. Amongst the topics that were discussed is the Continuing Professional Development (CPD) policy that was approved by Council: the term of office for the current Council and the two Professional Boards which is coming to an end next year in June; voter education prior to nominations and elections; compliance to the Act by practitioners. Social service professionals seem not to be aware that annual fees are payable on or before the 1st January of every year as prescribed in the Social Service Professions Act 110 of 1978. The implied period of grace is creating a serious challenge for finance because practitioners wait until the 31st March to

make payments which prevents the finance department from reconciling payments and issuing receipts on time. Notices will be sent out highlighting those clauses which lead to deregistration such as paying late, not updating particulars, etc. A statement with more outcomes of this meeting will be issued shortly.

Social service professionals in Mpumalanga are invited to a registration outreach session to be held on 10 March 2020. Venue details will follow soon. The registration help desk will be on call to attend all registration related enquiries on the day.

NOT FOR OURSELVES

The Minister of Social Development on 24 March 2020 requested the Minister of Labour to include social service professionals into the list of persons providing essential services. Council also submitted recommendations in terms of section 3(c) of the Social Service Professions Act 110 of 1978 regarding matters that affect social service professionals to the Minister of Social Development for consideration.

Since the call for help, there has been short supply of protective kits to minimise the spread of the virus. Council with the assistance of HWSETA, supplied 3,000 antivirus self-care kits: 2.956 sanitizers. 3.690 washable masks to over 30 NGOs mostly affiliate members of NACOSS; City of Ekurhuleni social development; Gauteng social development; SANDF social work unit; 16 shelters for Gender-based Violence survivors in Mpumalanga and 1 in Lenasia; six community based organisations across Gauteng working with the homeless and social workers in private practice.

The Registrar participated in a webinar on the 3rd April, on trauma counselling facilitated by ASASWEI, Dr Nadesan offered by Prof Alida Herbst of the NWU.

Council wishes all social service professionals who are leading from the front to continue their selfless work in good health. Remain safe and practise good hygiene and self-care at all times.

As Council's secretariat, we are receiving large numbers of emails since COVID Alert Level 3 started. However, some emails are not clear and concise, which delays the response time. Help us to assist you effectively by ensuring the following with each email you send:

- Subject line: An appropriate and clear indication of the subject of your query in the subject line. Then we know who to refer it to
- · Proper greeting that is courteous salutation: Indicate the name of the person you are communicating to. In rare instances where you do not know a person's name or title, it is okay to use this salutation: To whom it may concern or simply, dear Madam or Sir.
- · Content of your email text: State the reason for your email. Provide as much information as possible regarding the subject. Please be specific and to the point.
- · Always include your full names and SACSSP registration number in all gueries. If you enquire about your registration status, as include your ID number, for example: Registration status; Sandra Sesele: 981231 5555 081. These are the only ways we can track your information.
- Things to avoid: Do not use shorthand or sms type language. Avoid using acronyms or social media 'lingo'.

UNLOCKING NEW WAYS UNDER LOCKDOWN

On 13 August 2020, Council convened the 53rd ordinary Executive Committee meeting. The meeting took stock of the quarter 1 organisational report for the 2020/21 financial year and an assessment on the impact of the national lockdown on operations of Council was done.

On 14 August 2020, the *Professional Board for Social Work* delegation held a virtual meeting with the *Association of South African Social Work Education Institutions* (ASASWEI) and all Higher Education Institutions (HEIs) providing training in social work. The purpose of the meeting was to discuss the challenges faced by 4th year student social workers, of whom majority are unable to undertake compulsory practicums, due to the national lockdown. The *Professional Board for Social Work* agreed that they will respond in writing to both ASASWEI and HEIs regarding these challenges.

On 17 August 2020, Council's senior staff attended the inaugural *Ministry of Social Development oversight forum* meeting led by the Acting Director General, Mr Linton Mchunu. The meeting laid a strong foundation for regular oversight meetings and paved way for the development of a stakeholder compact and identified areas of work for the benefit of the social service sector and the public at large.

On 19 and 20 August 2020, the *National Association of Child Care Workers* (NACCW) in partnership with the *South African Council for Social Service Professions*, *Quality Council for Trades and Occupations* (QCTO) and the *Health and Welfare Sector Education and Training Authority* (HWSETA) rolled out virtual workshops with 32 accredited Skills Development Providers(SDPs) on Child and Youth Care NQF level 5 generic learning material.

READY FOR THE 4TH INDUSTRIAL REVOLUTION?

On 26 August 2020. Council held its 59th meeting. Council deliberated and resolved, amongst others. on the following:

- Council approved the proposed fees payable for 2021/2022 for submission to the Minister to consider and publish for public comments
- Council directed in accordance with section 20(1) of the Social Service Professions Act 110 of 1978 that the names of persons who have not complied with the conditions related to their registration with the SACSSP be removed from the registers concerned.
- · Council noted the progress reports submitted the Professional Boards and committees on key strategic deliverables.

A statement on the 59th Council meeting will be issued soon.

On 31 August 2020. Council attended a virtual stakeholder engagement session organised by Health and Welfare Sector Education and Training Authority (HWSETA) under the theme "Training for skills and not jobs". Amongst other stakeholders that attended was the National Department of Social Development and the South African Federation for Mental Health. These stakeholders based on their different sectors presented skills development needs after the pandemic and in relation to the 4th Industrial Revolution and its effects. The 4th industrial revolution has changed the way the social service sector render its services. Reskilling of employees should be every employers' primary priority as there will be limitations to provide effective psychosocial services, due to lack of human interaction. Council's presentation recognised the need for social service practitioners to sharpen their skills within the context of the pandemic and a need for massive rollout of Child and Youth Care degree qualification in order to have more child and youth care workers qualifying with degrees.

PHASING INTO LEVEL 1

Management convened a special meeting to look at the possibility of increasing staff complement in the office to maximize responses to needs of the sector. A formal notice will be issued soon regarding implications of alert level 1.

Council's Communications and Public Relations Practitioner was invited to attend Seminar 1 of Webinar series: Promoting an Understanding of The Intersections between Violence against Women and Children on 15 September 2020, organised by the University of Cape Town's Children's Institute, the South African Medical Research Council's Gender and Health Research Unit and Sonke Gender Justice Panellists shared literature on intersections that are evident, that are known between childhood abuse and intimate partner violence. Data that was shared revealed that:

- Violence against women and children are occurrent problem, are driven by the same risk factor, and are sustained through intergenerational cycles.
- Violence against women and children are high in societies where there is high level of violence in general and high levels of gender inequality.
- Intersections between violence against women and children in settings of poverty and how violence against women and children affects health and in particular ill health.

Strategies to end violence against women and children will be presented on another webinar scheduled for 13 October 2020.

The SACSSP held a virtual bilateral meeting with delegation of Lesotho and the Department of Social Development International Relations Directorate from 14 until 15 October 2020. The government of Lesotho is in the process of drafting a Social Service Professions Bill and they toured Council to collect necessary information to be able to draft a piece of legislation for social service professionals in their country.

Council's Communication and Public Relations Practitioner attended the Portfolio Committee on Social Development virtual meeting on 21 October 2020 on the Cabinet resolution that was passed in 2018, that further affirmed that social workers must be appointed by all the departments that require them. An update on employment of social work graduates was presented. There is approximately 9000 unemployed social work graduates including those that are self-funded. The Department has reduced the social work scholarship and redirected the funding to absorb social work graduates; the department is engaging key stakeholders in unlocking more funds and more opportunities for these graduates.
