MEETING OF PROFESSIONAL BOARD FOR SOCIAL WORK STATEMENT ON 54th

30 August 2022

The Professional Board for Social Work (PBSW) held its 54th meeting on 17 August 2022 in Pretoria. Board Notice 316 of 2022 was published in Government Gazette 46705 of 12 August 2022 with a list of Members to serve on the 5th Council, 5th Professional Board for Social Work and 4th Professional Board for Child and Youth Care Work. As this was the first meeting of the newly constituted 5th Professional Board for Social Work the meeting was chaired by the Registrar Ms Langi Malamba in terms of Regulation 2 relating to Appointment of Office Bearers.

Members of the Professional Board nominated the Chairperson and Vice-chairperson in terms of Regulation 2 and the Registrar will inform the Minister of the nominations and request the Minister to appoint the Chairperson and Vice-chairperson in terms of Section 24(1)(gD)(ix). The nominated office bearers, Ms Ida Strydom (chairperson) and Ms Makau Morake (vice-chairperson) are in acting capacity until such time the Minister appoints them.

The acting chairperson chaired the second part of the meeting which dealt with the nomination of members to serve on the Section 10 committees. These committees assist in the execution of Council's powers and functions. The members of the Professional Board will attend an induction session together with the members of Council and the Professional Board for Child & Youth Care on a date to be confirmed. The date of the next meeting of the Professional Board will be confirmed once the calendar has been finalised.

The Acting chairperson of the Professional Board thanked all members for entrusting her to lead this Professional Board and encouraged the members to attend to the business of the profession within the mandate of the Board.
