TERMINOLOGY

"ballot paper" means a ballot paper used to cast a vote either in paper and/or electronic format

"candidate" means a person who has been nominated in terms of the Regulations and who qualifies to be elected, and whose name was announced in Board Notice 3 of 2022

"polling day" means the last day that a voter may vote (in the case of these elections it is 16 May 2022)

"registration category" means the category within which a person is registered in terms of the Social Service Professions Act 110 of 1978 and the relevant Regulations, and for the purpose of these elections the registration categories are social workers (10-), social auxiliary workers (50-), child and youth care workers (70-) and auxiliary child and youth care workers (90-)

"Regulations" means Regulations relating to election of members of the South African Council for Social Service Professions (Government Notice No R. 1698 published in Government Gazette 19644 of 31 December 1998); Regulations regarding the election and appointment of members of a professional board (Government Notice No 1427 published in Government Gazette 24039 of 8 November 2002); Regulations regarding the establishment and constitution of a Professional Board for Social Work (Government Notice No. R. 920 published in Government Gazette No 25109 of 27 June 2003) and/or Regulations regarding the establishment and constitution of a Professional Board for Child and Youth Care (Government Notice No. R. 377 published in Government Gazette No 25042 of 14 March 2003), and amendment(s) thereof, as applicable

"voter" means person registered in terms of the Social Service Professions Act 110 of 1978 and who are entitled to vote in terms of the relevant Regulations

INTRODUCTION

This brochure will assist registered social service professionals to participate in the upcoming elections of the South African Council for Social Service Professions (SACSSP) for the 5th Council, 5th Professional Board for Social Work and 4th Professional Board for Child and Youth Care Work

Please study it carefully.

Your SACSSP

The South African Council for Social Service Professions (SACSSP) is established as a juristic person in terms of section 2 of the *Social Service Professions Act 110 of 1978* as an autonomous statutory body for social service professions in South Africa. The SACSSP discharges its statutory mandate, subject to the provisions of the *Act* together with the *Regulations* and *Rules* thereto, as the determining, guiding and directing regulatory authority body for the social service professions of social work and child and youth care work in the country.

The SACSSP fulfils this role through Council constituted in terms of section 5 of the Act and the Professional Board for Social Work and the Professional Board for Child and Youth Care Work established in terms of section 14A of the Act. by:

- setting the standards for education and training of social service professionals (qualifications and continuous professional development);
- registration of social service professionals as a requirement to practice;
- setting standards for and exercise effective control over the professional conduct (including ethics) of social service professionals; as well as
- taking policy resolutions as guidelines for the practising of the social service professions under its auspices.

Thus, protecting the integrity of the social service professions as well as the interest of the public at large.

It is a legal requirement in terms of the *Social Service Professions Act 110 of 1978* for a social worker, social auxiliary worker, student social worker, student social auxiliary worker, child and youth care worker (professional level), child and youth care worker (auxiliary level) and student child and youth care worker (at professional level or auxiliary level of study) to be registered and in good standing in terms of his or her registration as condition to practise.

NOMINATIONS

In 2020, nominations were called for (see *Board Notice* 3 of 2021 published in the Government Gazette No 44173 of 5 February 2021) and received in terms of the *Regulations relating to election of members of the South African Council for Social Service Professions* (Government Notice No R. 1698 published in Government Gazette 19644 of 31 December 1998) to serve on the 5th Council in terms of section 5(1)(a) and (b) of the Act and

the Regulations regarding the election and appointment of members of a professional board (Government Notice No 1427 published in Government Gazette 24039 of 8 November 2002) to serve on the 5th Professional Board for Social Work and 4th Professional Board for Child and Youth Care Work in terms of the Regulations regarding the establishment and constitution of a Professional Board for Social Work and the Regulations regarding the establishment and constitution of a Professional Board for Child and Youth Care.

The names of the persons nominated were announced in Board Notice 218 of 2021, dated ,which is also the names that appear in this brochure on page 4-8.

ABOUT THE ELECTIONS

The election of Members to serve on the 5th Council, 5th Professional Board for Social Work and 4th Professional Board for Child and Youth Care Work of the SACSSP is prescribed in detail in the *Regulations* and managed by the Registrar in her capacity as Returning Officer. The election process is generally same for Members to serve on Council and the Professional Boards, with slight differences that will be explained. Please note that this brochure provides a non-legal and user-friendly explanation of the election procedures, and if you want more information please consult the mentioned Regulations on the SACSSP's website (www.sacssp.co.za).

The election of Members to serve on the 5th South African Council for Social Service Professions (SACSSP), 5th Professional Board for Social Work and 4th Professional Board for Child and Youth Care Work will take place in two main ways:

Election of Members will be through the prescribed electronic election procedures where eligible voters will complete an <u>electronic/online Ballot Paper</u> and submit it online using a secure link (recommended method of voting)

OR

Election of Members will be through the prescribed manual election procedures where eligible voters will complete paper Ballot Paper and submit it in the prescribe manner in the case where a voter is not able to vote through an electronic/online Ballot Paper or opt in writing not to use an electronic Ballot Paper.

POLLING DAY

Polling day is the last day of the voting period when votes may casted and accepted by the Returning

This day as determined and indicated in <u>Board Notice</u> <u>248 of 2022</u> publish in Government Gazette 46288 of 29 April 2022, is

16h00 on 16 MAY 2022

No late ballot papers will be accepted.

THE 2022 SACSSP ELECTIONS EXPLAINED

WHO MAY PARTICIPATE (VOTE) IN THE ELECTIONS?

You are according to Regulations entitled to vote:

- (a) if you are registered with the SACSSP in terms of section 17 as a social worker, section 18 as a social auxiliary worker, and section 18A as a child and youth care worker and auxiliary child and youth care worker of the Social Service Professions Act 110 of 1978 may vote in accordance with a Regulations; and
- (b) if you are a South African citizen

Practically, if you are registered as a social worker, social auxiliary worker, child and youth care worker or auxiliary child and youth care worker, and your annual fees are paid up to date, you may vote for the persons you wish to represent your profession on the SACSSP.

In this brochure the term "voter" refers to a person as indicate above.

WHO MAY NOT PARTICIPATE IN THE ELECTIONS

The following persons **are not allowed to vote** according to the Regulations:

- (c) student social workers, student social auxiliary workers, student child and youth care workers and student auxiliary child and youth care worker are not allowed to vote.
- (d) a person, even if registered in terms of sections 17, 18 and 18A of the Social Service Professions Act 110 of 1978, who is not a South African citizen¹

CATEGORIES FOR ELECTION

Voters, depending on their profession, may only vote in specific categories for nominated candidates. There will be clear instructions on the ballot papers. This table will also help you to know on which ballot paper you should vote:

BALLOT	Category
If you are a SOCIAL WORKER registered in terms of section 17 of the Act, you may vote in the following two categories on BALLOT PAPER 1A and BALLOT PAPER 2	
1A	section 5(1)(a): six (6) social workers elected by social workers to serve on the 5th Council (maximum 6 votes)
2	regulation 3(a): four (4) social workers elected by social workers to serve on 5th Professional Board for Social Work (maximum 4 votes)
If you are a SOCIAL AUXILIARY WORKER registered in terms of section 18 of the Act, you may vote in the following category in BALLOT PAPER 2	
2	regulation 3(h): one (1) social auxiliary worker to serve on 5th Professional Board for Social Work (maximum 1 vote)
If you are a CHILD AND YOUTH CARE WORKER or AUXILIARY CHILD AND YOUTH CARE WORKER registered in terms of section 18A of the Act, you may vote in the following two categories on BALLOT PAPER 1B and BALLOT PAPER 3	
1B	section 5(1)(b): election of three (3) child and youth care workers to serve on the 5th Council
3	regulation 3(a): election of five (5) child and youth care workers to serve on the 4th Professional Board for Child and Youth Care Work

ELECTRONIC election procedures explained

STEP 1: RECEIVE AN ELECTRONIC/ ONLINE BALLOT PAPER

- The Returning Officer will issue a **link** to the **electronic/online BALLOT PAPER** by email, WhatsApp or SMS to each eligible voter as follows:
 - Each registered **social worker** eligible to participate in the election will receive a link to Form B.1.1E which will contain the electronic/online BALLOT PAPER 1A and BALLOT PAPER 2 (part for election of four social workers in terms of regulation 3(a)).



- Each registered social auxiliary worker eligible to participate in the election will receive a link to Form B.1.2E which will contain the electronic/online BALLOT PAPER 2 (part for election of one social auxiliary worker in terms of regulation 3(h)).
- Each registered child and youth care worker and auxiliary child and youth care worker eligible to participate in the election will receive a link to Form B.1.3E which will contain the electronic/online BALLOT PAPER 3.
- It will include the Voter's Declaration of Identity.
- The link will take the voter to the mentioned Ballot Paper where he or she can
 participate in the elections.
- Each Ballot Paper will be considered and counted separately in terms of the applicable Regulations.
- If you received this electronic/online Ballot Paper as well as a paper Ballot Paper, or more than one Ballot Paper, only one (1) may be completed.

STEP 2: PREPARE TO ELECT CANDIDATES

- · Open the link to access the Ballot Paper received.
- Make sure that the Ballot Paper received is the correct Ballot Paper linked to your registration category.
- DO NOT proceed if you have received an incorrect Ballot Paper. Contact the Returning Officer immediately at <u>elections@sacssp.co.za</u>
- Carefully study the voting procedures BEFORE you vote.
- · Read ALL the instructions.
- Read this brochure to get to know the candidates eligible to be elected
- Make sure you know whom you want to vote for before you proceed. You will not be able to change your votes once you have submitted the electronic/ online Ballot Paper.

STEP 3: CAST YOUR VOTE

- Each voter needs to cast his or her vote on the ballot paper(s) applicable to him or her, which are included in Forms B.1.1E, B.1.2E and B.1.3E respectively.
- A voter may only vote for candidates in the categories associated with his or her category of registration.
- · Read and follow the instructions on the Ballot Paper
- Each voter shall be entitled to vote for the number of candidate(s) per category on the ballot paper and shall vote by marking the space opposite the name(s) of the candidate(s) for whom he/she wishes to vote.
- NOTE: Please make sure that you know who you want to vote for before making
 the space for your vote on the ballot papers. After completing your votes and the
 submission of the Ballot Papers, you will not be able to change your votes.
- You need to insert your SACSSP registration number on the Ballot Paper as your voter identification. This is required to verify whether you are an eligible voter and have voted in the correct category.

STEP 4: VOTER'S DECLARATION OF IDENTITY

- In order to ensure that the vote casted is an authentic and legitimate vote by a social service professional registered in terms of sections 17, 18 or 18A of the Social Service Professions Act 110 of 1978 you need to complete the Voter's Declaration of Identity with all the information required.
- This is your declaration as voter that you are entitled to participate in the elections.
- The information required here are similar to the information that are kept by the SACSSP on the Registers as required in terms of section 19 of the Social Service Professions Act 110 of 1978.
- · Read and follow the instructions.
- DO NOT submit your Ballot Paper without completing this part. If the Voter's
 declaration of identity is not completed or completed incorrectly, your Ballot Paper
 will be classified as spoiled, and your votes will not be counted.

STEP 5: SUBMIT YOUR VOTE

After completing Voter's declaration of identity, press the **SUBMIT** button to cast your vote. Note, after pressing this button you will not be able to return to the Ballot Paper.

Your voting is now completed

MANUAL (paper-based) election procedures explained

STEP 1: RECEIVE THE PAPER BALLOT PAPER

- The Returning Officer to will issue a paper Ballot Paper to
 - A voter who has no email address entered against his or her name on the Register kept in terms of section 19 of the Social Service Professions Act 110 of 1978 shall be required to only use the paper ballot paper manual procedures for the purpose of the elections. Such Ballot Paper will be dispatched via postal mail to his or her postal address as on the said Register; and/or
 - A voter who received an electronic/online ballot paper whom expressly
 informed the Returning Officer in writing by 3 May 2022 that he or she
 wishes to cast his or vote on paper ballot paper, where after such ballot
 paper will be dispatched to him or her in the prescribe manner.
- Each registered social service professional referred to above and who is entitled (allowed) to vote will receive:
 - a unique consolidated ballot paper that contains four (4) distinct ballot paper containing the names of the nominees who may be voted for, as well as the instructions on how to vote and in which category he or she may vote
 - a Voter's Declaration of Identity envelope to be completed and to place the ballot paper in
 - a cover envelope to place the identification envelope (with the ballot paper inside) in and return to the SACSSP
- Please keep this safe as only one unique paper ballot paper is sent to each voter as indicated above.
- Each Ballot Paper will be considered and counted separately in terms of the applicable Regulations.
- If you received this electronic/online Ballot Paper as well as a paper Ballot Paper, or more than one Ballot Paper, only one (1) may be completed.

STEP 2: PREPARE TO ELECT CANDIDATES

- Carefully study the Ballot Papers and voting procedures BEFORE you vote.
- Read ALL the instructions.
- · Read this brochure to get to know the candidates eligible to be elected
- Make sure you know whom you want to vote for beforeyou proceed. You will not be able to change your votes once you have submitted the electronic/ online Ballot Paper.
- A voter may only vote for candidates in the categories associated with his or her category of registration.
 - If you are a social worker registered in terms of section 17 of the Act, cast your votes on BALLOT PAPER 1A and BALLOT PAPER 2.
 - If you are a social auxiliary worker registered in terms of section 18 of the Act, cast your vote on BALLOT PAPER 2.
 - If you are a child and youth care worker or auxiliary child and youth care worker registered in terms of section 18A of the Act, cast your votes on BALLOT PAPER 1B and BALLOT PAPER 3.
- Make sure that you know which Ballot Paper is applicable for your registration category and for how many candidates you may vote for.

STEP 3: CAST YOUR VOTE

- Each voter needs to cast his or her vote on the ballot paper(s) applicable to him or her, which are included in Forms B.1.1E,
- B.1.2E and B.1.3E respectively.
 A voter may only vote for candidates in the categories associated with his or her category of registration.
- Read and follow the instructions on the Ballot Paper.
- Each voter shall be entitled to vote for the number of candidate(s) per category on the ballot paper and shall vote by placing a clear cross (X) opposite the name(s) of the candidate(s) with a pen.
- NOTE: Please make sure that you know who
 you want to vote for before making a cross (X) on the ballot paper. After you made
 a cross (X) (voted) it cannot be changed, and if changed, the votes on the ballot
 paper for that category are spoiled and none of the votes casted in that category
 will be counted.
- You need to insert your SACSSP registration number on the Ballot Paper as your voter identification. This is required to verify whether you are an eligible voter and have voted in the correct category.


STEP 4: VOTER'S DECLARATION OF IDENTITY

- In order to ensure that the vote casted is an authentic and legitimate vote by a social service professional registered in terms of sections 17, 18 or 18A of the Social Service Professions Act 110 of 1978 you need to complete the accompanying Voter's Declaration of Identity envelope with all the information required.
- This is your declaration as voter that you are entitled to participate in the elections.
- The information required here are similar to the information that are kept by the SACSSP on the Registers as required in terms of section 19 of the Social Service Professions Act 110 of 1978.
- · Read and follow the instructions.
- A completed Voter's Declaration of Identity envelope is required for you to submit your Ballot Paper. If it is not completed or completed incorrectly, your Ballot Paper will be classified as spoiled, and your votes will not be counted.

- Fill in all the details that are required on the Voter's Declaration of Identity envelope.
- Your name does not appear on the Ballot Paper, and the Voter's Declaration of Identity envelope is the way in which the Returning Officer verifies that the ballot paper received, which is inside the envelope, is from a voter who is entitled to vote. (see Step 5).

STEP 5: PREPARE TO SUBMIT YOUR BALLOT PAPER

- Fold and place the *completed* Ballot Paper inside the *Voter's Declaration of Identity* envelope and **seal** the envelop.
- Please do not re-open Voter's Declaration of Identity envelope after it has been sealed
- Next place the Voter's Declaration of Identity envelope in the cover/returning envelope, which has the SACSSP's postal address on the outside, and seal it.
- Please note, you do not have put a postage stamp on the returning envelope, the postage will be paid by the SACSSP.



STEP 6: RETURN YOUR BALLOT PAPER

- Post the returning envelope to the Returning Officer, SACSSP, Private Bag X12, Gezina, 0031 (no stamp needed, postage cost is covered by the SACSSP)
- before or on 16h00 on 16 May 2022. It can also be delivered by hand to the SACSSP's offices at 37 Annie Botha Avenue, Riviera, Pretoria not later than 16h00 on 16 May 2022.
- IMPORTANT: A paper ballot paper submitted by postal mail must reach the Returning Officer no later than 20 May 2022 and will only be accepted as a valid ballot paper if the date stamp of the Post Office shows that it was mailed before or on 16h00 on 16 May 2022. Any paper ballot paper posted after 20 May 2022 shall be rejected.
- Please note, you do not have put a postage stamp on the returning envelope, the postage will be paid by the SACSSP.



IMPORTANT: Please post as early as possible, as to ensure that your ballot paper reaches the Returning officer at the SACSSP in time.

Your voting is now completed

NO STAMP NEEDED

Please note, you do not have to put a postage stamp on the returning envelope, the postage will be paid by the SACSSP.

BALGOBIND, Chandika (10-18168)

Ms Balgobind holds a BA in Social Science and Honours Degree in Social Work from UNISA. She has 24 years' experience in the NGO welfare sector and is currently the Director

at Pietermaritzburg Children's Home. She was the Chairperson of uMgungundlovu District Welfare Liaison Committee in KZN for 3 years, a supervisor for 3rd and 4th year social work students from UNISA, a member of the Pietermaritzburg and District Community Chest Council for 4 years; member of the Executive Board of CINDI (Children in Distress Network) for 4 years promoting networking within the children's sector; executive member at SAIF (SA Institute for Fundraising, KZN) for 3 years; Chairperson of the KZN Provincial and Midlands Welfare Social Services and Development Forums for 14 years facilitating training workshops, advocacy, and research. She is the National Deputy Chairperson of NACCW from 2017 till present, Deputy Chairperson of NACCW in KZN



DE SOUSA, Amanda Maria (10-13085)

Ms De Sousa holds a BSocSc. (Hons) from the University of KwaZulu-Natal. She is the Director at the Durban Child and Youth Care Centre since 1994. She has volunteered at the NACCW and was

the Regional Chairperson of KZN Executive 2001/2004 and Vice Chairperson KZN Executive 2004/2008. Ms De Sousa was a coordinator for KZN Principals Forum in 2009/2016 and 2021 and is a DQA Team Member.



GALLANT, Elwin Edgar (10-07085)

Mr Gallant completed a Masters Degree in Social Work in 1992 at the University of Port Elizabeth and also Completed the National Diploma in Child and Youth

Care (cum laude) in 2002 at Technikon SA. He is currently employed as a social worker with Department of Social Development in Port Elizabeth. He also worked in residential child and youth care and the Department of Sport, Arts and Culture. He has been actively involved with the National Associations of Child Care Workers (NACCW) since 1991 and is currently serving as the National Chairperson of the NACCW and also a Member of the SACSSP. He views himself as a humble servant leader who focuses his energy and time on advocating for those who cannot speak for themselves, the poor and vulnerable members of society as he is striving to be bright in the corner where he is.



KHEU, Thabiso Petrus (10-20241)

Her employment included community investment; social work practice, policy, research, student assessment, fieldwork tutoring and supervision at 3 universities. Ms Mathye served on the national committees and continues as a Board member. She is a Neuro-coach practitioner, ETDP certified facilitator, HWSETA registered assessor and moderator and a member of COMENSA. Ms Mathye was a panellist at the World Summit on Social Development (2002) and coordinated South Africa's preparations for the 4th UN World conference on Women.

Dr Mbedzi is the Head of Social Work Department at University of South Africa (UNISA). He obtained his PhD from UNISA and his research interests

He co-authored several books including Person-Centred Facilitation (2013), Introduction to Social Work in the South African Context (2015) and Theories for Decolonial Social Work Practice in South Africa (2019). He served in different committees in the South Africa Council for Social Service Profession (SACSSP) including the Continuing Professional Development (CPD) and Social Auxiliary Work (SAW) Learning Material Assessment Committees. He is also involved in multiple community work projects and serves in different committees within the university (UNISA).



MDLETSHE, Thokozile Prudence (10-16995)

Ms Mdletshe obtained her BA Social Work (Hons) from the University of Zululand and Project Management from the Durban University of Technology.

She has 25 years of social work experience. She worked for the Department of Social Development and is currently employed by Department of Health in KwaZulu-Natal as a social work manager at Mahatma Gandhi Memorial Hospital in Durban. She is Chairperson of the KZN Health Social Worker's Forum, responsible for liaison between social workers and the employer regarding operational issues. In 2018 she successfully led a provincial collaboration between social workers and UKZN Social Work Discipline to host a conference aimed at re-engineering social work

services within KZN-health, thereafter co-presented a paper on this collaboration at the ASASWEI conference.

DID YOU KNOW?

Section 3 of the Social Service Professions Act 110 of 1978 sets out a large part of the mandate of the SACSSP that needs to be executed by the Members to be elected to serve on the 5th Council. (see summary below)

The SACSSP has a clear statutory purpose prescribe by the Social Service Professions Act 110 of 1978

The objects (or purpose) of Council as set out in section 3 of the Act are summarise below:

- to protect and promote the interests of the professions in respect of which Professional Boards have been or are to be established and to deal with any matter relating to such interests;
- 2. to *maintain and enhance the prestige, status, integrity and dignity of the professions* in respect of which Professional Boards have been established:
- 3. to advise the Minister in relation to any matter affecting the professions in respect of which Professional Boards have been established;
- 4. to control and to exercise authority with regard to all financial matters relating to Council and the professional boards;
- 5. to consult and liaise with relevant authorities on matters affecting the Professional Boards in general;
- 6. to *determine*, on the recommendation of the Professional Boards, the *qualifications for the registration* persons practising professions in respect of which Professional Boards have been established;
- 7. to *regulate the practising of the professions* in respect of which Professional Boards have been established and *the registration of persons* practising other professions in respect of which Professional Boards have been established;
- to determine the standards of professional conduct of persons practising professions in respect of which Professional Boards have been established and to ensure that they are maintained;
- to exercise effective control over the professional conduct of persons practising professions in respect of which Professional Boards have been established;
- 10. to encourage and promote efficiency in and responsibility with regard to the practice of the professions in respect of which Professional Boards have been established;
- 11. to assist in the *promotion of social services* to the population of the Republic;
- 12. to advise the Minister on the amendment or adaptation of this Act, in particular to place greater emphasis on *professional practice, democracy, transparency, equity, accessibility and community need and involvement*;
- 13. to control and to exercise authority in respect of all matters affecting -
