REQUEST FOR LISTS OF NAMES OF SOCIAL SERVICE PROFESSIONALS TO VERIFY THE REGISTERS KEPT IN TERMS OF SECTION 19 OF THE SOCIAL SERVICE PROFESSIONS ACT 110 OF 1978

- 1. The Registrar is required in terms of section 19 of the Social Service Professions Act 110 of 1978 ('the Act") to keep Registers for social workers, social auxiliary workers, student social workers, student social auxiliary workers, child and youth care workers, auxiliary child and youth care workers, student child and youth care workers or student auxiliary child and youth care workers registered with the SACSSP in terms of the Act, which shall include the particulars as prescribed in the respective Regulations.
- 2. The SACSSP's Secretariat continues to experience high volumes of unopened return postal mail and emails, which cause concern as its registered persons are not receiving documents, including receipts and practice cards, from the SACSSP. Therefore, the Secretariat decided to embark on a process to verify and update the Registers kept in terms of section 19 of the Act through employers of social service professionals.
- 3. All employers of social service professionals and social service professionals in private practice, except for the Department of Social Development and the Department of Health, are requested to assist the SACSSP with this verification and updating action by submitting name lists of social service professionals in their employment as on 1 July 2024 by 31 July 2024.
- 4. The list should be prepared in the following format indicating the professional groups (social workers and child and youth care workers) and registration categories separately
