**OVER 65 YEARS:** In terms of Regulation 3 of the Regulations relating to fees payable by social workers, child and youth care workers, social auxiliary workers, auxiliary child and youth care workers, student social workers, student social auxiliary workers, student child and youth care workers and student auxiliary child and youth care workers published as R.3485 in government gazette No. 48693 of 2 June 2023 , any person who in the course of the financial year attains the age of 65 years on or before 31 March of that financial year, shall be exempted from payment of the annual fee and still be allowed to practice if he/she wishes to, subject to an application, as prescribed.
